



Self-Measurement Form

In all instances, hold tape firm and level, but not tight.



a. Full height, from the top of your head to the floor.

b. Neck Circumference: Wrap tape around to the base of your front neck and allow room for wearing comfort; OR measure the collar length of a favourite shirt.

c. *Sleeve Length: From the centre back (CB) of your neck with your arm slightly bent, follow the tape around to your wrist bone.

d. Chest: Wrap a tape measure evenly around the fullest part under your arms.

e. Waist: Wrap a tape around your natural waistline,- around your tummy button.

f. Seat/Hip: Standing with your feet together, measure around the fullest part of your hip (approx. 7-8" below the waist). Don't forget to keep the tape level.

g. Inseam: Best taken from an existing pair of trousers you like. Measure along the garment inseam from the crotch seam to the hem.

h. Glove Hand: Measure all the way around the flat part of your hand, excluding the thumb, and around the widest part at the knuckles. Refer to sizing on product page to convert this measurement in inches to your corresponding glove size.

Proposed Amendments to IAATI Constitution

ARTICLE 2. MEMBERSHIP

Section 2. Affiliate Membership

Any representative of any company, organization, business or philanthropic endeavor known or believed to be beneficial to the best interests and objectives of the Association, and who contributes an annual sum of not less than of an Active membership fee, and is not less than eighteen years of age is eligible for membership an Affiliate member. Membership shall be granted at the discretion of the Executive Board. Affiliate members shall have the privileges of an Active Member, and can hold the office of President or Vice President as long as the below parameters are met:

1. The Affiliate member must be a current Director or Associate Director and have been engaged in the Association for 5 years. Engaged is described as attending conferences, participating in board meetings, chairing committees and showing value to the association.

2. There can only be one Affiliate member in the chairs (4th Vice President, 3rd Vice President, 2nd Vice President, 1st Vice President, and President) at a time. The Affiliate member must either be outgoing President or the immediate Past President before the nominating committee will consider another Affiliate member as 4th Vice President.

Article 2

Section 5. Application for Membership

Applications for Active or Affiliate Membership shall be made to the Executive Director, with recommendations by a current member in good standing, to include life members and past presidents.

ADD the Following:

Any person accepting membership in IAATI agrees to abide by the Association's rules, policies and Code of Ethics. Members found to be in breach of the Code of Ethics may be subject to disciplinary measures.


Where in the World? By Paul Thomas



Success Story

Cooperation between Shelter Insurance's Special Investigations Unit and The Robison Group Investigative Solutions leads to a success story.

A claim was filed with Shelter Insurance for the theft of a Toyota Corolla in Arkansas in July 2017. The claim was assigned to The Robison Group Investigative Solutions for field investigation related to the theft. The Claims Department learned the vehicle had recently been titled and registered in California. With this new title Shelter was unable to obtain a salvage title.

The local California police auto-theft task force was unsuccessful confirming the vehicle's presence at the registration address during drive-by spot checks of the residence.

A license plate reader search revealed several matches at various locations, and most recently, a Home Depot parking lot and a housing complex. A May 2018 match showed the vehicle parked on the street in what appeared to be a new or expanding housing development with ongoing construction. It was not clear if the vehicle was parked at a residence or in the construction area.

The investigator reviewed Google Maps satellite and street view for the location. In doing so, a late model, dark colored Toyota sedan was seen parked in a driveway directly across from where the match was recorded. The street view of the license plate was blurred, but the date of the street view photograph was labeled May; the same month the license plate reader recorded the vehicle at that address.

More database research found records that showed the residence was recently purchased by a family whose prior addresses also corresponded with the earlier license plate reader matches found in other areas. Later, a license plate registration inquiry confirmed the homeowner and vehicle owner were the same.

Our field investigator went to this address in California and observed the vehicle. Local law enforcement was contacted, but they disclosed the vehicle was not currently listed as stolen via NCIC. We contacted law enforcement in Arkansas who immediately re-entered the vehicle into NCIC as active and stolen. Before the police in California arrived, the vehicle departed the residence and our investigator followed. Our investigator communicated with police in real time updating the vehicle's movements and location. The police eventually stopped the vehicle and impounded it.

Our investigator was able to determine the vehicle was sold at a lien sale in Arkansas and then resold via the website OfferUp to the current registrant.

Shelter Insurance appealed to the State of California DMV requesting they withdraw the incorrectly issued title and registration thus rendering it null and void. Once this administrative part of the process is complete, the vehicle will be sold via an auto auction with the proceeds being properly directed to Shelter Insurance and the claim will be closed.

This is an example of cooperation and investigative partnership between an insurance company's claims department, Special Investigations Unit and an investigation firm working together for a successful outcome.

Resolution for Watch Your Car Program

Whereas: The ATPA Committee recognizes the Watch Your Car Program was adopted under the United States Federal Motor Vehicle Theft Prevention Act of 1994, and subsequently published in the Federal Register on August 6, 1996.¹

- Whereas: The Watch Your Car Program is a national voluntary effort that encourages owners of motor vehicles to display a light reflective decal or sticker on the rear window of their vehicle to alert police that their vehicle is not normally driven between the hours of 1 a.m. and 5 a.m.
- Whereas: Since adoption under the United States Code, versions of the national program have been adopted by some states, local jurisdictions and auto theft prevention programs.²

Whereas: The ATPA Committee received a report from the Intelligence Analysts Workgroup which provided background, rationale, case study, challenges, and recommendations.

- Therefore: Based on consultation with representatives from the ATPA Committee, the Watch Your Car Program would be recommended for IAATI to support an existing or new programmatic implementation under the following conditions:
 - The programmatic owner would perform a jurisdictional legal analysis which demonstrates applicability for implementing or continuing the Watch Your Car program, including consideration on elements of the program not creating intrusive police activity which would infringe on personal rights of citizens,
 - The programmatic owner has on-going impact analysis of the Watch Your Car Program which identifies and manages the number of registrants enrolled in the program, awareness, and training to law enforcement, and ability to dis-enroll registrants that either no longer poses the previously enrolled vehicle or desire to no longer participate,
 - 3. The programmatic owner performs an annual administrative analysis on the performance and effectiveness of Watch Your Car Program, which may include the number of active registrants, number of dis-enrolled registrants, number of vehicles which were identified as being stolen at the time of the police stop, etc.

Adopted:

This resolution is adopted by the IAATI ATPA Committee on the 9th day of May 2019.
