

# **Conference Updates continued**

#### Self-Measurement Form

In all instances, hold tape firm and level, but not tight.



a. Full height, from the top of your head to the floor.

b. Neck Circumference: Wrap tape around to the base of your front neck and allow room for wearing comfort; OR measure the collar length of a favourite shirt.

c. \*Sleeve Length: From the centre back (CB) of your neck with your arm slightly bent, follow the tape around to your wrist bone.

d. Chest: Wrap a tape measure evenly around the fullest part under your arms.

e. Waist: Wrap a tape around your natural waistline,- around your tummy button.

f. Seat/Hip: Standing with your feet together, measure around the fullest part of your hip (approx. 7-8" below the waist). Don't forget to keep the tape level.

g. Inseam: Best taken from an existing pair of trousers you like. Measure along the garment inseam from the crotch seam to the hem.

h. Glove Hand: Measure all the way around the flat part of your hand, excluding the thumb, and around the widest part at the knuckles. Refer to sizing on product page to convert this measurement in inches to your corresponding glove size.

# **Proposed Amendments to IAATI Constitution**

## ARTICLE 2. MEMBERSHIP

## Section 2. Affiliate Membership

Any representative of any company, organization, business or philanthropic endeavor known or believed to be beneficial to the best interests and objectives of the Association, and who contributes an annual sum of not less than of an Active membership fee, and is not less than eighteen years of age is eligible for membership an Affiliate member. Membership shall be granted at the discretion of the Executive Board. Affiliate members shall have the privileges of an Active Member, and can hold the office of President or Vice President as long as the below parameters are met:

1. The Affiliate member must be a current Director or Associate Director and have been engaged in the Association for 5 years. Engaged is described as attending conferences, participating in board meetings, chairing committees and showing value to the association.

2. There can only be one Affiliate member in the chairs (4th Vice President, 3rd Vice President, 2nd Vice President, 1st Vice President, and President) at a time. The Affiliate member must either be outgoing President or the immediate Past President before the nominating committee will consider another Affiliate member as 4th Vice President.

## Article 2

## Section 5. Application for Membership

Applications for Active or Affiliate Membership shall be made to the Executive Director, with recommendations by a current member in good standing, to include life members and past presidents.

ADD the Following:

Any person accepting membership in IAATI agrees to abide by the Association's rules, policies and Code of Ethics. Members found to be in breach of the Code of Ethics may be subject to disciplinary measures.


# Where in the World? By Paul Thomas



#### **Resolution for Watch Your Car Program**

Whereas: The ATPA Committee recognizes the Watch Your Car Program was adopted under the United States Federal Motor Vehicle Theft Prevention Act of 1994, and subsequently published in the Federal Register on August 6, 1996.<sup>1</sup>

- Whereas: The Watch Your Car Program is a national voluntary effort that encourages owners of motor vehicles to display a light reflective decal or sticker on the rear window of their vehicle to alert police that their vehicle is not normally driven between the hours of 1 a.m. and 5 a.m.
- Whereas: Since adoption under the United States Code, versions of the national program have been adopted by some states, local jurisdictions and auto theft prevention programs.<sup>2</sup>

Whereas: The ATPA Committee received a report from the Intelligence Analysts Workgroup which provided background, rationale, case study, challenges, and recommendations.

- Therefore: Based on consultation with representatives from the ATPA Committee, the Watch Your Car Program would be recommended for IAATI to support an existing or new programmatic implementation under the following conditions:
  - The programmatic owner would perform a jurisdictional legal analysis which demonstrates applicability for implementing or continuing the Watch Your Car program, including consideration on elements of the program not creating intrusive police activity which would infringe on personal rights of citizens,
  - The programmatic owner has on-going impact analysis of the Watch Your Car Program which identifies and manages the number of registrants enrolled in the program, awareness, and training to law enforcement, and ability to dis-enroll registrants that either no longer poses the previously enrolled vehicle or desire to no longer participate,
  - 3. The programmatic owner performs an annual administrative analysis on the performance and effectiveness of Watch Your Car Program, which may include the number of active registrants, number of dis-enrolled registrants, number of vehicles which were identified as being stolen at the time of the police stop, etc.

Adopted:

This resolution is adopted by the IAATI ATPA Committee on the 9<sup>th</sup> day of May 2019.
