### **SPEAKER BIOGRAPHIES**



**Geoff Hughes**, Chief Executive, National Motor Vehicle Theft Reduction Council (NMVTRC)

Geoff Hughes joined the NMVTRC in April 1999 after an extensive career in road transport policy at both a state and national level. As the NMVTRC's Director of Strategy and Programming, Geoff was responsible for the NMVTRC's strategic planning, research and communications activities.

Following the retirement of its founding Executive Director, Ray Carroll, the Council appointed Geoff as his successor and Chief Executive in September 2018.

Geoff has played an influential in role in improving information exchange between key agencies and the management of written-off vehicles nationally. He has also led the development of the NMVTRC's young offender programs and has been part of advisory boards overseeing related programs in Victoria, Western Australia, Queensland, Tasmania and New South Wales.

In a 13 year career with Victoria's road transport agency, Vicroads, Geoff worked in a wide variety of policy development and management roles ranging from commercial vehicle operations to traffic management to road safety.

In 1993 Geoff joined the then National Road Transport Commission where he led the development of a series of major reforms to Australia's road transport laws.



**Renato Schipani**, Criminal Intelligence Officer, Criminal Networks Sub-directorate, INTERPOL, Lyon, France

Renato Schipani was born in 1962 in Ludwigshafen am Rhein (Germany), his parents having immigrated from a little village from Calabria in the south of Italy. Being born abroad gave Renato a kind of imprinting to his current internationally oriented life.

After living for 9 years in Germany, he and his family returned to Italy, to Civitavecchia, a port town 70 km north of Rome. In 1998 he got a

degree at the University La Sapienza of Rome in Foreign Modern Languages and Literatures. He joined Italian State Police in 1992. After his police education in Reggio Emilia, he was assigned to the Immigration Unit at the International Airport of Roma -Fiumicino where he worked as Immigration officer from 1993 to 1996. In May 1996 he was assigned to INTERPOL Roma, more specifically, to the International Car Trafficking Unit.

Since April 2008 he has been seconded as Criminal Intelligence Officer to INTERPOL's General Secretariat in Lyon (France) where he is still working as Coordinator of the global vehicle crime program.

In all, he has 21 years of experience in this field during which time he has had the privilege of meeting and working with many experienced officers from all over the world. Field investigations, Operations, executions of Letters of Requests on behalf of Judicial Authorities and Training have been and are the ingredients of his day-to-day activities.

A range of free interactive data tools and mapping services that enable stakeholders to undertake their own detailed analyses of motor vehicle theft are available on the NMVTRC's website. This includes customised dashboards for members of law enforcement, enabling local police to quickly visualise crime trends and implement more operational responses<sup>\*</sup>.

Robert is a member of the Drugs and Organized Crime Sub-Directorate at INTERPOL and working in the Stolen Motor Vehicle Unit. In this role, he is responsible for monitoring and analyzing global crime trends, organizing conferences spanning both public and private sector, assisting in the development of cutting-edge tools and systems designed for global law enforcement, as well as policy and

project drafting and analysis.

He has a M.A in International Relations from the University of Melbourne after an exchange semester at Malmö University, Sweden. His areas of study range from geopolitical risk analysis, to transnational trade and governance, to policy-writing and implementation. He also completed a Bachelor Degree at the Royal Melbourne Institute of Technology (RMIT), focusing on International and Global Studies. These studies included an internship at the Australian Federal Police.





George Baker serves as GM's primary interface to the local, national and international vehicle crime investigation community. He leads the Global Vehicle Security Team, working with technical experts in all areas of vehicle security to ensure GM identifies and counters emerging vehicle crime trends to provide optimal vehicle security to GM product owners.

Prior to this assignment, Baker held a number of positions at General Motors, dating back to July 1995. He first served as a locomotive program manager in Mexico and Russia. He then led GM's automotive activity in Russia, overseeing an emerging dealer network spread over eleven time zones. In early 2000, he became director of GM Military Trucks, leading the development and deliveries of specially-modified trucks to major military and federal agencies in the United States and overseas. In April 2004, he became OnStar's public policy manager and primary liaison to law enforcement, assisting with expansion of services in the US, Europe, Mexico and South America.

Before beginning his corporate career, George served in the US Army as an armor officer and Russian Foreign Area Officer. A retired lieutenant colonel, he holds an engineering degree from West Point and a master's degree in Russian area studies from Harvard University.





Ben LeMere, CEO and Co-Founder of Berla Corporation (USA)

Ben is a widely-recognized subject matter expert in digital forensics and cybersecurity, with more than 20 years of military and government service.

Under Ben's leadership, Berla successfully continues to support the global law enforcement community while also beginning to establish roots in the commercial realm by supporting a broader investigative community and automotive manufacturers.



**Andreas Koeck**, Deputy Head of the Task Force Vehicle Crime Austria from the Criminal Intelligence Service (BKA), Austria

Andreas Koeck is an expert in the area of organized crime. For more than 30 years working at the police, including the last nine years in his current position.

Andreas is an expert for vehicle identification, international and

national trainer in this field, including regularly conducting Interpol Training classes. He will present classes on the identification of Germany made vehicles (BMW, Mercedes, Audi, VW, etc.) and on current electronic theft methods.



Nick Mayell, Police Liaison and Training Officer, Datatag Ltd. (UK)

Nick is a well-known name in equipment security and police circles. He left school at the age of 16 and secured a position as an apprentice heavy vehicle mechanic with a local plant and truck company. He later went on to manage a hire company which is when he became brutally aware of the financial repercussions of heavy equipment theft. As more and more of his equipment became subjected to theft, he took it

upon himself to trace and recover his own machines. Such was his success, insurance and finance companies continued to use his investigative skills to help locate their own assets.

In 1994 Nick was employed by a specialist heavy equipment investigation company in the UK and worked on many high profile cases, including one case which led to the recovery of 86 stolen machines. In 2011 he left to set up Plant Theft Consultancy. Nick's services are currently secured by the UK's leading asset marking and registration company, Datatag ID Ltd, who are the administrators the CESAR scheme. In his role with Datatag Nick works directly with the police, crime prevention organisations and the insurance and asset finance industries to raise the level of awareness and increase the level of detection of vehicle enabled crime. Nick present special training courses to disseminate proven vehicle identification techniques for traffic police, as well as advanced courses for specialist vehicle examiners and training to insurance underwriters and claims officers, asset finance underwriters and fraud investigators.

Nick is a qualified trainer who regularly runs courses through the UK and Europe including for Interpol's Formatrain project and IAATI. His heavy equipment course is internationally recognised and accredited at level 3. He also runs a level 3 accredited courses in forensic vehicle VIN recovery, using both chemical and thermal techniques.

**Det. Senior Constable Cathy Horton,** Major & Organised Crime Squad, Auto Theft Unit.

Cathy Horton has been a serving Police Officer for 15 years with the Queensland Police Service and an investigator for 12 twelve of those years. She commenced work within the specialised policing establishment of State Crime Command 11 years ago, and during this

# **Australasian Branch IAATI Awards**

The Australasian Branch Awards have been recognising achievement in the fight about auto crime since 1999 through it Awards Program. The awards seek to recognise and reward outstanding achievement, innovation, or exceptional performance in the field of auto theft prevention, detection and investigation.

In 2019 there will be five categories of awards: and the winners will be announced during the 2019 Annual Training Seminar Dinner to be held in Sydney on 1st March 2019. Recipients of the Investigation of the Year award, the President's award, the Insurance Industry Investigation of the Year award and the Forensic & Supporting Services Award will each receive up to \$1,500 towards the cost of attending the 2019 Seminar .

#### **Investigation of the Year**

The Investigation of the Year award is open to any individual or team who have conducted an outstanding investigation involving the detection and prevention of auto crime. It is open to members of police forces, customs services, insurance investigators, private investigators, or anyone else involved in vehicle theft investigations.

Submissions will be judged on their demonstration of any or all of the following criteria: innovative methodologies, application of best practice investigation techniques, the complexity of the investigation, and co-operation and involvement of multiple agencies to achieve a result in the fight against auto crime.

The investigation may involve cooperation of international agencies but at least part of the investigation must have taken place in either Australia, New Zealand or South East Asia during the last 3 years.

#### Insurance Industry Investigation of the Year

The Insurance Industry Investigation of the Year Award is open to any individual or team working in the insurance industry who have conducted an outstanding investigation of a suspicious motor vehicle claim, or a network of suspicious motor vehicle claims or any auto crime claims (staged accident etc.). The award is open to both investigators who have conducted an outstanding investigation into motor vehicle theft claims, auto crime claims, and claims staff working in the investigations unit of an insurance company who manage the investigation process.

The investigation may be deemed outstanding for a range of reasons including its use of innovative methodologies and investigations techniques; the complexity of the investigation and the outcome of the investigation. The submission could be in relation to one specific claim, a network of theft claims or auto crime claims that were identified and investigated. The investigation and/or insurance claim must have been performed in either Australia, New Zealand or South East Asia in the past three years.


